#### **EQUIPMENT:**

Equipment and systems covered by this Certificate are as follows:

Power Control Unit Type 9410 is used to distribute supply voltage to Power Rail Type 9400 on which it is mounted.

The Control Unit is connected to an external power supply and optionally to a back-up power supply.

The Control Unit detects errors from the modules mounted on the rail and provides a collective status alarm via a potential free contact.

Ambient temperature range -20 °C to +60 °C.

#### Electrical data

Power Supply (terminals 31, 32): U =  $21.6 \dots 26.6 \text{ Vdc} / 4 \text{ Adc}$ . Backup Power Supply (terminals 33, 34): U =  $21.6 \dots 26.6 \text{ Vdc} / 4 \text{ Adc}$ . Power Rail (rear contacts): U =  $21.6 \dots 26.6 \text{ Vdc}$  (with transient suppression to 40 V). Power Rail StatusRelay (terminals 11, 12, 13): Umax = 30 Vdc or 32 Vac, Imax = 2 A.

If the control Unit is installed outside the hazardous area, the following data for the relay contacts apply (unclassified installation): Umax = 30 Vdc or 250 Vac, Imax = 2 A

### SPECIFIC CONDITIONS OF USE: YES as shown below:

The Power Control Unit Type 9410 and Power Rail Type 9400 shall be installed in a controlled environment with suitably reduced pollution, limited to pollution degree 2 or better.

The circuit shall be limited to overvoltage category I/II as defined in IEC 60664-1.

The Power Control Unit Type 9410 and Power Rail Type 9400 shall be installed in a suitable enclosure, in conformity with type of protection Ex n or Ex e and providing a degree of protection of at least IP54.
